



Application for MHSA Human Services Scholarship

Amador Community College Foundation, a 501(c)(3) entity doing business as “Amador College Connect” (ACC) administers Amador County Behavioral Health Department’s “MHSA Human Services Scholarshipⁱ” to support the professional development of eligible residents who want to work in the field of public mental health. MHSA Scholarship funds may be used to cover tuition, fees, and books and other program benefits for eligible students who enroll in Coastline College’s Human Services Certificate program. Scholarship recipients must apply for financial aid through the FAFSA process and, if qualified, use those resources first.

MHSA Scholarship applicants must meet the following eligibility requirements:

- Maintain their residence in Amador County
- Provide income documentation supporting an annualized income which is less than the “Very Low Income” threshold pursuant to HUD guidelines. For 2023-2023 the upper limit is \$32,100 for a family of one and \$45,850 for a family of four.
- Have a desire to work in the field of public mental health and register for required classes at Coastline Community College with the goal of completing the Human Services Certificate.

Priority is given to those who have personal, first-hand experience with mental illness, either as a client or family member of a client.

Scholarship students who successfully complete the Human Services Certificate may be eligible to apply for additional funding to earn an A.A. degree from Coastline College in an eligible “helping field.”

Applications are accepted on an ongoing basis.

_____ I will apply to Coastline College and complete the FERPA waiver of confidentiality to allow Coastline College and Amador College Connect (ACC) to exchange information about my enrollment and grades; I will also provide my Coastline student ID number to the ACC Coordinator.

_____ I will complete the FAFSA/California Promise Fee Waiver application for Financial Aid.

_____ I will complete the Student Success and Support Steps at Coastline which include Orientation, Assessment, and a phone appointment with a Coastline counselor.

_____ I will return in good condition and by the due date set by ACC any texts or course materials purchased or rented by ACC.

_____ At the beginning of each semester I will log into MyCCC and for each course in which I am registered I will determine the dates for (i) Tuition Refund Deadline; (ii) the Last Day to Drop Without a “W.” I understand that dropping a class after the tuition refund deadline or receiving a “withdrawal” grade (“W”) will negatively impact my ability to continue in the MHSA Human Services Scholarship program.

_____ I will strive to pass all classes with a grade of “C” or better and will utilize ACC’s free tutoring and/or mentoring if needed. I will also meet with Amador College Connect staff or representative if I make less than a “C” in any course before I enroll in the next semester. I understand that absent special circumstances, the Scholarship will not cover tuition or other costs for any course that must be repeated.

_____ I will notify ACC as soon as possible if I believe I may need an accommodation due to a disability and I will collaborate with Coastline’s Department of Special Programs to set up my accommodation.

_____ I will provide ACC with proof of my grades for each semester.

_____ I will attend cohort meetings at ACC, typically three per semester, and complete participation surveys and other documents, as requested.

_____ I will abide by all policies and procedures governing the Program’s Internship and stipend opportunities.

_____ Upon completion of the certificate requirements, I will apply for graduation and provide ACC with a copy of my Certificate, and/or A.A., diploma(s).

Further, I understand that my ability to continue in the Program may be limited in the following situations:

_____ I withdraw or drop a class without first consulting with a representative of ACC.

_____ I drop a class after its Refund deadline, receive a “W” or “No Show” grade in a class.

I understand and agree that if I fail to meet the above commitments, my scholarship will be withdrawn for future semesters. MHSA Human Services Scholarship program is funded by the State of California and I understand that program requirements are subject to change from time to time.
